District Profile

Manang District is a part of Province No. 4, is one of the seventy-seven districts of Nepal. The district, with Chame as its district headquarters, covers an area of 2,246 km² and had a population (2011) of 6,538. The pass of Thorung La at 5415 meters above the sea connects the district to Mustang District by providing a route between the towns of Manang and Muktinath. Manang district gets least amount of rainfall among districts of Nepal as it lies to the north of the Himalayas which blocks monsoon air. The Manang Valley, which lies close to the Nepal-Tibet border, Nar and Phu villages are border to Tibet.

Program

HURON team reached Chame at Manang district on November 10, 2017 and conducted training. The duration of training program was 7 hours (9am to 4pm). The opening ceremony was chaired by District President. The training program was conducted by Human Rights Trainers, member and program officers. 66 participants from different background attended the program with an aim to have a better understanding of the Concept Fundamental Rights, International Laws and Treaties, Gentlemen's Agreement, Civil Rights, Good Governance, Federalism, Crisis Management and Sustainable Development Goals.

After the inaugural ceremony, the training was held. The training team were Senior Advocate Mr. Dinesh Tripathy, HURON General Secretary Mr. Mahamunishwor Acharya and HURON Program Coordinator MR. Sambhu Kumar Lama.

There were total 50 participants where HURON members, Media Personnel, Security personnel (Nepal police and Armed Police Force), students, teachers etc. were attended. Out of 50 participants 12 were female and 38 were male.

The overall development goal of the one day educational training program was to train and educate members about Human Rights issues.
